112.Presentation - CCBC Youth Service; Gemma Marks

Gemma Marks has worked for CCBC Youth Service for 20 years and is based in 'The Basement' in Blackwood which is an information and advocacy drop-in centre for young people aged 11-25 years. Gemma is also the senior youth worker at the Van Community Centre club, which operates on Wednesdays during term time from 6 pm to 8 pm. She outlined the work of the Youth Service, current delivery and future planned activities at the Van Centre.

The youth club attracts about 20 young people per week on average.

The assistance and knowledge of the of the Youth Service during the playscheme in summer 2019 was noted and discussion how this can be incorporated in future delivery of similar provision was discussed.

During her presentation, there were several interruptions due to anti-social behaviour by young people at the Community Centre and the Caretaker and Police were called. This caused a delay.

ACTION: Clerk to arrange a meeting between all partners who could assist with the delivery of the Summer Scheme in 2020.

115. Councillor Vacancy

The Clerk confirmed that following the 'Notice of Vacancy' period for the seat in Lansbury ward, previously held by Plaid Cymru, a request for an election had been received by the Returning Officer. In was noted that this was requested by representatives of Plaid Cymru. Currently awaiting a timeline for the election process which will be confirmed by the Electoral Services Manager at CCBC shortly. An indication of cost for this is circa £5,000.

Clir T Graham noted that whilst the request for an election is offered in community council rules and democratically correct, the morality of spending in the region of 20% of the annual precept of a small community council and tax payers money on this was morally questionable and was disappointed and angered by Plaid Cymru's actions. This view was endorsed by all Councillors. As a result of this, the budget for 2020-2021 will need to be revised and adjusted to meet the unexpected cost of the election

- 117.2 The PETRA book launch will be on 8th April at 12.15 pm at St James ICC. Cllr T Graham will attend to represent Van CC. All councillors are invited and to confirm to the Clerk if planning to attend. Cllr B Jones gave her apologies
- 117.3 Christmas Event. Due to the earlier decision on Christmas lighting, possible alternative options outlined in the report are not appropriate. It was AGREED to hold an event similar to last year. As Fridays are not an option at the centre it was agreed that Saturday 12th December is the preferred date

- 117.4 The Clerk provided recent information with regards to the summer playscheme. It was noted that Sarah Mutch has additional responsibilities and it appears she and her team will be unable to lead on the project. This is a concern to Members. Alterative options are currently under discussion between Sport Caerphilly and the Parent Network regarding hosting sessional workers. This delay and vague arrangements for the

- scheme is an issue and could impact on the submission of a timely bid to the National Lottery 'Awards for All' fund as agreed to support the running costs of the project <u>ACTION</u>: Clerk to arrange a meeting with all partners urgently
- 117.5 An option of providing access to supported places to residents in wards MA2 and MC polling districts to the Sport Caerphilly Summer Scheme at Caerphilly Leisure Centre was discussed. It was AGREED that this was not appropriate at the current time and residents of these areas should be made aware of the availability of the scheme at the Van Community Centre
- 117.6 Members noted update on Bonfire Night event planning meeting and some of the main issues and obstacles were discussed in more detail. Next meeting on 27th February 2020. Cllr Leek to confirm if can attend
- 117.7 Members noted the proposed 10% increase in hire charges at the Van Centre. Requested the Clerk seeks clarity if this is a rise across the board for all hirers. It was AGREED that the Clerk should request where the audited accounts for Van Centre Management Committee can be viewed. In addition, the Van Community Council AGREED to formally write to request a place of the management committee for the centre.

- 117.8 Members AGREED that the draft proposals for changes to the electoral boundaries in Caerphilly were appropriate and no formal response from Van CC was required to be submitted to the Boundary Commission.
