It should be stressed that the nominated member needs to be mindful that whilst being a community (or Town) councillor, they will sit upon the committee as a charity trustee first, and all input and decisions should be made distinctly in the interests of, and for the benefit of the charity. Please note that this provision is optional and your Council is not bound to make a nomination.
