#### 123.Community Safety Report

PC Moore advised that, overall, the area had adhered to social distancing and lockdown restrictions over the past few months as a result of COVID19. There has been some increase in domestic violence and violent crime, which follows the trends across the country as a result of the lockdown. There have been two instances of stabbings, one in Van area and one close to the Van CC area. Both were dealt with swiftly and suspects arrested, and ongoing action is being taken. The Black Live Matters protest a few weeks ago attracted approximately 250 protestors. This was arranged by a lady in the Van CC area who has worked closely with police to adhere to COVID regulations. A further protest is planned for Saturday, 20<sup>th</sup> June and in the region of 1000 are expected to attend. Site visits have been made and plans are in place to support the need to social distance. Cllr Jones quested an update on the alleged sexual assault at the nearby Cwm Leyshon quarry and PC Moore provided an update on the information known to him. The issue of off-road bikers and concerns to public safety were raised. Police advised that 2 bikes had recently been confiscated. Any assistance from the public on the home location of the offending bikers would be welcomed. The police are planning an operation specifically to deal with off-road bikes in the forthcoming months.

The Chair thanked officers for joining the meeting and the update and they left the meeting.
